Quote: (On the U.S.' strategy towards the Asia-Pacific) "What does that regional strategy look like? For starters, it calls for a sustained commitment to what I have called "forwarddeployed" diplomacy. That means continuing to dispatch the full range of our diplomatic assets --- including our highest-ranking officials, our development experts, our interagency teams, and our permanent assets -- to every country and corner of the Asia-Pacific region. Our strategy will have to keep accounting for and adapting to the rapid and dramatic shifts playing out across Asia. With this in mind, our work will proceed along six key lines of action: strengthening bilateral security alliances; deepening our working relationships with emerging powers, including with China; engaging with regional multilateral institutions; expanding trade and investment; forging a broad-based military presence; and advancing democracy and human rights. By virtue of our unique geography, the United States is both an Atlantic and a Pacific power. We are proud of our European partnerships and all that they deliver. Our challenge now is to build a web of partnerships and institutions across the Pacific that is as durable and as consistent with American interests and values as the web we have built across the Atlantic. That is the touchstone of our efforts in all these areas. Our treaty alliances with Japan, South Korea, Australia, the Philippines, and Thailand are the fulcrum for our strategic turn to the Asia-Pacific. They have underwritten regional peace and security for more than half a century, shaping the environment for the region's remarkable economic ascent. They leverage our regional presence and enhance our regional leadership at a time of evolving security challenges. As successful as these alliances have been, we can't afford simply to sustain them -- we need to update them for a changing world. In this effort, the Obama administration is guided by three core principles. First, we have to maintain political consensus on the core objectives of our alliances. Second, we have to ensure that our alliances are nimble and adaptive so that they can successfully address new challenges and seize new opportunities. Third, we have to guarantee that the defense capabilities and communications infrastructure of our alliances are operationally and materially capable of deterring provocation from the full spectrum of state and nonstate actors."

Quote: "I mean, as an aside, it's one of the reasons why I went to Asia first on my first trip and why I've just had published this long article in Foreign Policy, because it appeared to Asians – both our allies, like Japan and the Philippines or Australia and others – that we were ceding the Asia Pacific region because we were so preoccupied in the Middle East and Iraq and Afghanistan and Pakistan. And I wanted to send a very clear signal, no, we are a global power. We are an Atlantic power and a Pacific power, and we are a power to be reckoned with in the Asia Pacific. "

October 25, 2011 Foreign Ministry Spokesperson Jiang Yu's Regular Press Conference (Foreign Ministry Spokesperson Jiang Yu's Regular Press Conference on October 25, 2011)

Quote: "China upholds the strategy of peaceful development, actively advocates a new thinking on security featuring mutual trust, mutual benefit, equality and coordination and promotes cooperation and good-neighborliness with its neighbors. Safeguarding regional peace and stability is in the common interests of all countries in the region. At present, all countries in the South China Sea region pledge to handle maritime disputes peacefully and appropriately through dialogue and consultation in a bid to safeguard regional peace and stability and sound bilateral relations. We hold that it is imperative that relevant countries earnestly implement the Declaration on the Conduct of Parties in the South China Sea, which is vital to safeguarding and enhancing mutual trust between the countries. We maintain a smooth channel of communication and consultation with countries directly involved in the South China Sea dispute. Countries outside the region should respect the efforts by countries within the region to solve the issue through dialogue and consultation. Artificially creating tension and confrontation is not conducive to the settlement of the issue, but will only complicate it. We do not want to see any country creating troubles or interference in the South China Sea issue by any country outside the region."

October 25, 2011 Global Times Editorial (Don't take peaceful approach for granted) Quote: "Conflicts and disputes over the sovereignty of the seas in East Asia and South Asia are complicated. No known method exists to solve these issues in a peaceful way. Although China has proposed a strategy that calls for countries in the region to put away differences and work on shared interests, few have responded. The reality is that each country in the region believes it has what it takes to force China to bow down. China wants to remain calm but it is a lonely role to play. China will have to adjust itself for this reality."

Quote: (Regarding a question about the concern Asia-Pacific countries have about the reduction of U.S. budget and whether that would lead to a reduction U.S. forces in Asia) "You know, there's no question that those concerns have been expressed, and the purpose of my visit is to make very clear to this region and to our allies in the Pacific that we – and when I say we, the president of the United States and the Department of Defense – made very clear that the Pacific will remain a key priority for the United States, that we will maintain our force projection in this area, that we will maintain a presence in this area, that we will remain a Pacific power, and that we will do whatever we can to try to work with the nations of this area to develop a strong security and cooperative relationship. I've made clear that even with the budget constraints that we are facing in the United States, as we have developed a strategy to deal with that and try to develop a future strategy for what our defense will look like in the future, that there is no question in discussions within the Pentagon and discussions with the White House that the Pacific will be a priority for the United States of America."

Quote: "And the message that I want to send is simple. The United States is and always will be a Pacific power, and we are here to stay. The forward presence of U.S. forces here is not merely a symbol of U.S. commitment to Japan, but also a symbol of our commitment to the peace and security that must exist across the Pacific region." "We also stated our desire to continue to work together to strengthen bilateral security cooperation with the Republic of Korea as well as with Australia to more effectively address the many shared challenges that we face. Together we will also work to encourage China's emergence as a responsible and positive partner in building regional stability and prosperity, cooperating on global issues and upholding international norms and rules of behavior." "It's no secret that the United States faces some very tough fiscal decisions back home. But let me reassure the people of Japan, let me reassure you as secretary of defense that the one thing that we have determined in discussions as to our future strategy, the one thing we are agreed up on is that the Pacific will remain a key priority. I will continue to strengthen our forces in this part of the world."

October 26, 2011 China Daily Editorial (Comments add to tensions)

Quote: "Judging from the remarks made by US Defense Secretary Leon Panetta in his on-going Asia tour, it is crystal clear that Washington is involving itself deeper in the affairs in the Asia-Pacific region." "In a meeting with defense ministers from ASEAN in Bali, Panetta said: "I want to reiterate that the United States is a Pacific nation with enduring interests and commitments to our allies and partners in the region." To further reassure its allies in the region, in Japan, Panetta said that the looming cuts in US defense spending would not affect its ability to maintain a strong military presence in the Pacific. Given that a handful of countries in the region have covertly or overtly courted the US support in their disputes with China over the South China Sea issue and that the US has openly made a link between the waters and its interests, the Pentagon chief's stance could embolden those countries to slip further along the road of confrontation." "The US may have justifications for reshaping its Asia policy as it readjusts it global strategy. But, if, in any way, the US manifesto for a presence in Asia leads to an escalation of tension in regional disputes, it can only be bad news for countries in the region. It would certainly have an adverse effect on Sino-US relations."

Quote: "America is a resident military, diplomatic and economic power in the Asia-Pacific -- and we will remain an Asia-Pacific power. No region of the world matters more to our future in the new century unfolding before us." "It is important to put the significance of our alliance in a global context. Today the world and the United States stand at a pivot point. As Secretary Clinton has said, the Asia-Pacific region is now a key driver of global politics, and greater U.S. commitment here is essential. After World War II, America built a strong and lasting network of institutions and relationships across the Atlantic -- one that pays off to this day. We must now do the same across the Pacific. The time has come for the United States to redouble our investments as a Pacific power, a strategic course set by President Obama from the outset of his administration and one that is already yielding benefits. These benefits go both ways: just as Asia is critical to America's future, an engaged America is vital to Asia's future. And there is no question that our treaty alliance with Japan is the fulcrum for our strategic turn to the Asia-Pacific."

Quote: "The strategic goal of the US in the South China Sea is maintaining a situation of no war and no peace. The US has no direct concerns in Asian ocean disputes. So why does it take such a strong role in the dispute? This is part of the global strategy of the US, balancing powers in different regions, as it has done in the past. It also interferes in the Taiwan Strait and causes tension on the Korean Peninsula. However, the US feels that this is not enough to disturb China's development, and now it's trying to stir up Southeast Asia to make trouble for China."



Quote: First and foremost, our approach to China begins with robust engagement across the Asia-Pacific. [...] because we believe that a peaceful and prosperous region is the single best foundation to support strong and stable U.S.-China relations" "Second, we are committed to expand cooperation with China on a range of pressing transnational issues." "But [...] a narrow focusing on areas of agreement is not enough given the challenges we face together. We cannot simply turn away from our disagreements over Chinese challenges to maritime rights and freedom of navigation when China has yet to clarify its claims in the South China Sea in terms consistent with international law. We cannot ignore the potentially destabilizing nature of China's rapid military modernization, when its capabilities and intentions remain opaque. And when incessant cyber attacks on public and private American entities continue to emanate from China, we cannot help expressing our concern." (On the United States and China Security Strategic Dialogue and other such high level talks)"The purpose of these mechanisms is to create channels of communication that enhance, transparency, predictability, and, ultimately, trust." "This first guiding principle is the importance of enhancing transparency." "The second principle is creating greater predictability in our relationship to develop better understanding of one another's practices, norms, and intentions." "Finally, our engagement requires frank and open communication, particularly about one another's goals and intentions."

Quote: "And of course closer to home, we are working together to facilitate the peaceful rise of China as a nation that plays a constructive and responsible role in the region and in the world commensurate with its growing economic stature. Both of us seek to engage China in ways that promote greater respect for the rule of law and adherence to international norms."

• October 26, Global Times Editorial (Panetta skips China, nothing to worry about) Quote: "The newly appointed US Defense Secretary Leon Panetta decided not to visit China during his first Asian trip. It may further indicate that the US is about to shift its strategic focus back to Asia." "It is practically impossible for one US defense secretary, or even one US president, to decide the overall Sino-US relationship. Those who can decide are people from both countries, as it will determine their fate along with East Asia's, and perhaps even the whole world. China needs to stay calm and accept challenges and burdens as it has the world's second largest economy." "The US will surely take advantage of the South China Sea dispute to challenge China. Countries involved in the dispute will also help the US to achieve this goal. This is not that terrible. There is no reason to be overly worried about the consequence of conflict." Quote: "(Regarding China's economic development) there are great pockets of wealth and success, but that isn't reflected in the overall standard of living, and our national wealth is so much greater, many times over, than China's. So let's put this into some perspective about what's actually real and what is feared or a source of anxiety." "[...] the Chinese have more to do to stimulate internal demand, not to be artificially inflating their exports by depreciating their currency, and all anybody's asking for is a fair field for competition. And if we can't win on a fair field, that's fine. But when you're fighting with two hands tied behind your back because of all kinds of advantages for state-owned enterprises, for currency pegging, for not protecting intellectual property rights, I mean, there's a long list of concerns that Americans have brought to me and that I have shared with the Chinese." "[...] we don't want to spark any kind of retaliatory trade war that will disadvantage the global economy, the U.S. economy. We want to move toward a framework of rules that will be followed by everybody."

Quote: "On the economic front, the United States and China need to work together to ensure strong, sustained, and balanced future global growth. In the aftermath of the global financial crisis, the United States and China worked effectively through the G-20 to help pull the global economy back from the brink. We have to build on that cooperation. U.S. firms want fair opportunities to export to China's growing markets, which can be important sources of jobs here in the United States, as well as assurances that the \$50 billion of American capital invested in China will create a strong foundation for new market and investment opportunities that will support global competitiveness. At the same time, Chinese firms want to be able to buy more high-tech products from the United States, make more investments here, and be accorded the same terms of access that market economies enjoy. We can work together on these objectives, but China still needs to take important steps toward reform. In particular, we are working with China to end unfair discrimination against U.S. and other foreign companies or against their innovative technologies, remove preferences for domestic firms, and end measures that disadvantage or appropriate foreign intellectual property. And we look to China to take steps to allow its currency to appreciate more rapidly, both against the dollar and against the currencies of its other major trading partners. Such reforms, we believe, would not only benefit both our countries (indeed, they would support the goals of China's own five-year plan, which calls for more domestic-led growth), but also contribute to global economic balance, predictability, and broader prosperity."
